Payment should be sent with classified ads to help keep the cost of classified advertising down. Billing adds extra cost. Word count is based upon the spaces between words in normal usage. Tear sheets are only supplied with display ads when they're billed. Since classified ads are not billed, no tear sheets are sent.

First-time advertisers should send an endorsement from their pastor along with their ad to their local conference communication director. Include checks and envelopes addressed to each union paper with appropriate postage attached. The conference communication director sends the approved ad and checks on to the union papers in the envelopes you've provided, along with a copy of the pastor's endorsement. After the first time, ads may be sent directly to the union papers.
